- (#5) Receive instruction from the COMPANY NURSE and send student/client to one of the authorized Worker's Compensation clinics (ATTACHED) if more than minor first aid care is required.

NOTE: IN CASE OF EMERGENCY, CONTACT THE LOCAL PARAMEDICS OR CALL 911.
